QUALIFICATIONS

As the position is funded through Canada Summer Jobs, the student must meet all the following criteria:

- Be between 15 and 30 years of age at the start of the employment;

- Be a Canadian citizen, permanent resident, or person to whom refugee protection has been conferred under the *Immigration and Refugee Protection Act*²; and,
- Be legally entitled to work in Canada in accordance with relevant provincial or territorial legislation and regulations.

- Self-motivated, 'got to make it happen' attitude and takes initiative with ability to work independently and as part of a team
- Strong problem solving and analytical skills
- Strong Interpersonal and communication skills
